I also made a comment on their forum about the Jon Benet Ramsey case. I made the comment because a person came to Columbus with a document that had been sent to our house at 1458 SW 15th Ave in the 1950's, but I did not know if my brother did, and our mom. This person by the name of Eric had his own copy of the document, but where he got it I do not know. First he said he was from Boston and then he said he was from Morgantown West Virginia where the Ramsey's had lived and Patsy Ramsey's had been Miss West Virginia.

During one summer he said he was going out to Colorado to work. So, I believed him. But when he came back supposedly from Colorado he had a car with Ohio plates on it. So, I do not think he ever went there. Why did he tell me that? Why was there also someone in Columbus that knew Paul Hogan, and went by the name of Susan Nelson, but really had a hyphenated name of Ramsey being a part of the hyphenated name
