**CONSENT ORDER TO DISCHARGE EDUCATIONAL LOAN
DEBT BETWEEN PLAINTIFF AND SALLIE MAE, INC.**

THIS MATTER having come before the court, pursuant to the agreement between Plaintiff, Amy Renee Bishop ("Plaintiff"), and Sallie Mae, Inc. ("Sallie Mae), to discharge educational loan debt; the parties being in agreement to the following provisions:

Plaintiff is indebted to Sallie Mae pursuant to the applicable terms of one (1) educational loan Promissory Note ("Promissory Note"), disbursed on August 30, 2004 ("Educational Loan"). As of the date of the filing of this adversary proceeding, there was a balance due and owing on the Educational Loan evidenced by the Promissory Note, including principal, interest and fees, in the aggregate amount of \$3,062.14.

IT IS HEREBY ORDERED that Plaintiff's liability on the educational loan debt owed to Sallie Mae, evidenced by the Promissory Note, referenced herein above, is hereby rendered dischargeable upon the grant of a general discharge in the Plaintiff's main bankruptcy case.
