Now comes the debtor/plaintiff, Suzanne C. Amer, and the United States Department of Education (“DOE”), a defendant in above-captioned adversary proceeding, and do hereby jointly stipulate to dismiss this proceeding without prejudice as to the defendant DOE alone.
