FINAL JUDGMENT


Pursuant to the Court’s Order filed on January 28, 2013, the jury verdict returned September 11, 2013, and the Court’s Orders filed on April 9, 2014, the Court issues Final Judgment as follows:

1. Plaintiffs are awarded damages from Defendants, ABC Debt Relief, Ltd. Co., The Debt Answer, LLC, Lloyd Ward, P.C. d/b/a Lloyd Ward & Associates, Lloyd Regner and Lloyd Ward jointly and severally as follows:
 - a. Plaintiff Dana Block is awarded damages in the amount of \$15,228.02 from Defendants ABC Debt Relief, Ltd. Co., The Debt Answer, LLC, Lloyd Ward, P.C. d/b/a/ Lloyd Ward & Associates, Lloyd Regner, and Lloyd Ward.
 - b. Plaintiff Greg Burk is awarded damages in the amount of \$2,375.10 from Defendants ABC Debt Relief, Ltd. Co., The Debt Answer, LLC, Lloyd Ward, P.C. d/b/a/ Lloyd Ward & Associates, Lloyd Regner, and Lloyd Ward.
 - c. Plaintiff Jessica Casey is awarded damages in the amount of \$10,519.13 from Defendants ABC Debt Relief, Ltd. Co., The Debt Answer, LLC, Lloyd Ward, P.C. d/b/a/ Lloyd Ward & Associates, Lloyd Regner, and Lloyd Ward.

- h. Plaintiff Vallery Mann is awarded damages in the amount of \$4,554.45.
 - i. Plaintiff Jo Minaya is awarded damages in the amount of \$33,594.69.
 - j. Plaintiff Brian Parker is awarded damages in the amount of \$15,125.35.
 - k. Plaintiff Christopher Pitre is awarded damages in the amount of \$23,902.63.
 - l. Plaintiff Tim Carr is awarded damages the amount of \$27,938.03.
 - m. Plaintiff Coddi Dean is awarded damages in the amount of \$3,702.58.
 - n. Plaintiff John Nelson is awarded damages in the amount of \$8,726.59
2. Plaintiffs are awarded damages from defendants ABC Debt Relief, Ltd. Co., The Debt Answer, LLC, Lloyd Ward, P.C. d/b/a/ Lloyd Ward & Associates, and Lloyd Ward jointly and severally as follows:
- a. Plaintiff Tim Car is awarded damages in the amount of \$2,927.50.
 - b. Coddi Dean is awarded damages in the amount of \$14,924.35.
 - c. John Nelson is awarded damages in the amount of \$88.80.
3. Plaintiffs are awarded liquidated damages from Defendants ABC Debt Relief, Ltd. Co., The Debt Answer, LLC, Lloyd Ward, P.C. d/b/a/ Lloyd Ward & Associates, and Lloyd Ward jointly and severally in the amount of:
- a. Plaintiff Dana Block is awarded damages in the amount of \$15,228.02.
 - b. Plaintiff Greg Burk is awarded damages in the amount of \$2,375.10.
 - c. Plaintiff Jessica Casey is awarded damages in the amount of \$10,519.13.
 - d. Plaintiff Victoria Castillo is awarded damages in the amount of \$642.70.
 - e. Plaintiff Jeremy Cozart is awarded damages in the amount of \$2,273.19.
 - f. Plaintiff Michael Frank is awarded damages in the amount of \$8,581.15.
 - g. Plaintiff Johnny Keel is awarded damages in the amount of \$8,144.24.
 - h. Plaintiff Vallery Mann is awarded damages in the amount of \$4,554.45.
 - i. Plaintiff Jo Minaya is awarded damages in the amount of \$33,594.69.
 - j. Plaintiff Brian Parker is awarded damages in the amount of \$15,125.35.
 - k. Plaintiff Christopher Pitre is awarded damages in the amount of \$23,902.63.
 - l. Plaintiff Tim Carr is awarded damages in the amount of \$30,863.53.
 - m. Plaintiff Coddi Dean is awarded damages in the amount of \$18,626.93.
 - n. Plaintiff John Nelson is awarded damages in the amount of \$8,815.39

4. Plaintiffs are awarded post judgment interest on all damages from April 4, 2014 until all damages are paid at the rate of 0.14%; and
5. Plaintiffs are awarded cost of court in the amount of \$12,471.01 and attorneys fees in the amount of \$433,874.24.
