## ARTICLES OF ORGANIZATION

Date: January 14, 2016

THE UNDERSIGNED, in order to form a limited liability company under and by virtue of the Maryland Limited Liability Company Act, Md. Corps & Assns. Code Ann., Section 4A-101 et seq (the "MD LLC Act"), does hereby acknowledge and certify to the Maryland State Department of Assessments and Taxation as follows:

FIRST: The name of the limited liability company (which is hereinafter called the "Company") is:

**FEDERAL DEBT ASSISTANCE ASSOCIATION, LLC** /

SECOND: The Company will operate perpetually or as long as allowable by Maryland state law.

THIRD: The purposes for which the Company is formed are:

(1) To provide consultation and services related to but not limited to debt validation, credit review, credit restoration and or privileges necessary, convenient, or appropriate for any of the purposes herein expressed.

(2) To do everything necessary and proper for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein before set forth, either alone or in association with other companies, corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental to or growing out of or connected with the aforesaid business or powers, or any part or parts thereof; provided, the same is not inconsistent with the laws under which this company is organized.

(3) To engage in any other lawful purpose and/or business.

(4) To have and exercise all powers now or hereafter conferred by the laws of the State of Maryland on limited liability companies formed pursuant to the Act.

(5) To do any and all things necessary, convenient or incidental to the foregoing.

The aforementioned enumeration of the purposes, objects and business of the Company is made in furtherance, and not in limitation, of the powers conferred upon the Company by law, and is not intended, by the mention of any particular purposes, object or business, to limit or restrict any of the powers of the Company. The Company is formed upon the articles, conditions and provisions herein expressed, and subject to all particulars and to the limitations relative to limited liability companies which are contained in the general laws of this State.

FOURTH: The present address of the principal office of the Company in the State of Maryland is 9904 Harford Road, Parkville, Maryland 21234. The Company shall have such other or additional offices as may, from time to time, be determined necessary by the Managing Member. The resident agent of the Company in the State of Maryland is Robert Pantoulis whose address is 9904 Harford Road, Parkville, Maryland 21234. Said resident agent is a citizen of the State of Maryland who resides in the State of Maryland.

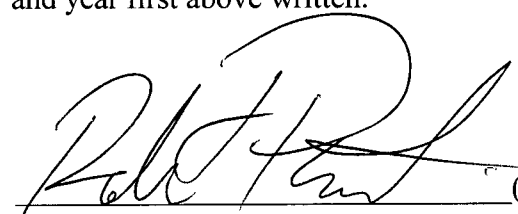
