AFFIDAVIT OF JE'HENNA WILLIAMSON

1. My name is Je'henna Williamson. I am an adult of sound mind. I reside in Plantation, Florida. I swear, under penalty of perjury, to the truth of each of the statements made in this Affidavit.

2. I worked as the Document Specialist Supervisor for National Legal staffing Support/Kevin Mason, P.A./GM Law Firm, LLC/Stuart Goldberg, PLLC, from July 2015 through July 18, 2018 – which was my final day working for the student-loan-fraud racket that is now operating as National Legal Staffing Support (“NLSS”) and GM Law Firm.

1 3. My daily job duties included: handling the uploading of client documents to the
2 NLSS system, communicating with clients about their accounts, and otherwise managing
3 the daily customer service aspects of what now operates as NLSS and GM Law Firm.

4 4. First, NLSS, Resolvly, LLC, and GM Law Firm are all controlled, if not entirely
5 owned, by a Florida resident named Gregory Fishman.

6 5. NLSS, Resolvly, LLC, and even GM Law Firm are not legitimately-separate
7 business entities. They are controlled, managed, and primarily, if not entirely, owned by
8 Gregory Fishman. These business entities are nothing more than alter egos for Gregory
9 Fishman to hide behind to conceal his racketeering activities.

10 6. These business entities – NLSS, Resolvly, and GM Law Firm – are fictions. They
11 are shell companies controlled by Gregory Fishman for the sole purpose of him
12 perpetuating, and profiting from, his frauds.

13 7. Based upon my three years of experience as the Document Specialist Supervisor,
14 I swear to the following facts:

15 (a) NLSS regularly (*i.e.*, daily) forges client signatures of legal documents, including client
16 retention agreements. This is a routine pattern and practice of NLSS management, as
17 directed by Gregory Fishman.

18 (b) The student loan resolution “program” marketed by the Defendants in this case, *Ali,*
19 *et al. v. Mason et al.*, is, indeed, a lie and a fraud. NLSS/GM Law Firm/Kevin Mason, P.A.,
20 simply steals their clients’ (victims’) money via the monthly auto draft payments that
21 NLSS/GM Law Firm/Kevin Mason, P.A., defraud from their clients (victims).

22 (c) Gregory Fishman recruits the attorneys who are complicit in this student loan
23 resolution racket. Gregory Fishman/NLSS/Resolvly have the entire marketing materials
24 (that are lies), payment structure, the entire racket set up. Gregory Fishman recruits’
25 attorneys with the lure of easy money to place their seals of authority onto this fake
26 student loan resolution “program.”

1 (d) Jon Sabia, a non-attorney employee of NLSS, effectively manages the attorneys
2 involved in this racket.

3 (e) Joe DeVito, a non-attorney employee of NLSS, is the Floor Manager. Joe
4 DeVito manages the cold-calling of the leads for Resolvly/NLSS and oversees and
5 manages the employees who are assigned to each client. Joe De Vito is responsible for
6 welcoming all clients in to the program. After efforts made to sign up clients (victims) of
7 this racket via the automated-dialing-system cold-calling to the cellular telephone numbers
8 of the Resolvly-sales-leads.

9 (f) Ari Pollard is the day-to-day Assistant Manager of Resolvly, who reports to, and
10 takes orders from, Gregory Fishman.

11 (g) There is no one qualified at NLSS to handle client legal matters. There are no
12 attorneys at NLSS, let alone paralegals.

13 (h) The bi-weekly “follow up” telephone calls made by NLSS/GM Law Firm to its
14 clients (victims) are nothing more than attempts to create legitimacy for a fake student loan
15 settlement “program”; and, perhaps even more importantly, these telephone calls serve to
16 allow NLSS/GM Law Firm to make sure that next month’s auto draft payment will go
17 through.

19 8. I am familiar with the pleaded facts and allegations in the Second Amended
20 Complaint filed in the *Ali, et al. v. Mason, et al.*, lawsuit, referenced on the cover page to this
21 Affidavit. These pleaded facts are true and consistent with my three years as the
22 Document Specialist Supervisor of NLSS/GM Law Firm.


