TERMS OF MEMBERSHIP AND MEMBERSHIP AGREEMENT

Auto Payment Assistance Terms & Conditions

Variety Investment Corporation, a Georgia Corporation ("Auto Payment Assistance") provides this autopaymentassistance.com web site ("Web Site") to you. This agreement is made between you and Variety Investment Corporation, ("AutoPaymentAssistance-"). What is Auto Payment Assistance ?

The Auto Payment Assistance Program is a unique program that will make a member's automobile payment when they cannot based on the schedule of conditions herein. (Hereafter all reference to payments will be referred to as "Benefits.") A member may earn up to three benefits based on the following:

- A.) A new member is entitled to (two) benefits the first year of his/her membership.
- B.) A second year member is entitled to (two) benefits the second year of his/her membership.
- C.) A third year member and all beyond are entitled to (three) benefits per year during the term of their membership.

All benefits cannot exceed the amount of \$500.

All membership fees must be current at the time that a member requests a benefit.

Member acknowledges by reading these terms and conditions that Variety Investment Corporation through its Auto Payment Assistance Program will make all benefit payments directly to member's auto loan or finance company.

THE PROCESS

Once APAC advances a benefit on behalf of a member to an approved financial institution, the member understands and agrees that the full amount of the benefit will be repaid to APAC over a (6) six month period interest free. The member will establish the repayment term at the time of receipt of the benefit.

EXAMPLE

—

A \$ 360.00 benefit may be repaid in six equal amounts of \$ 60.00 a month or (3) three payments of \$ 120.00 per month etc. The member selects the repayment term which must be paid within a six month period. All benefits are interest free and available to members in good standing pursuant to the enclosed terms and conditions.

All benefit repayments must be repaid by either

[Credit/debit card, checking account or employer direct deposit.](#)

There are absolutely no fees or interest charged on benefits to members. Repayment of benefits will begin (30) thirty days after the receipt of benefit payment from APAC. If a member cancels his/her membership prior to repayment of a benefit in full APAC shall deduct the balance in full from whatever source available. If a member does the agreed term of deduction account, the member agrees to additionally pay all costs of collection, recovery and/or legal fees.

These terms and conditions shall be governed by the laws of the state of Georgia.

Variety Investment Corporation (APAC) may refuse the disbursement of any benefit for any reason, to any member, that Variety Investment Corporation feels is not within these Terms and Conditions herein whether implied or not. All benefits are disbursed at the sole discretion of Variety Investment Corporation and not on the basis of a member's membership.

USE OF CONTENT AND SERVICES and INDEMNIFICATION
