### Mass Joinder Cases:

**What is a Mass Joinder?** There's a lot of confusion on the net about what a mass joinder is. Although mass joinder are sometimes referred to as class actions, they are not. There are 2 main differences between a mass joinder and a class action. In a class action you do not have to contact an Attorney to be in a class action, if you have had relations with the party being sued in the case. In a mass joinder you have to be accepted by the Attorney to join. Additionally in a class action the awarded money is split between everyone which means you end up with about ten dollars. In a mass joinder only those named plaintiffs share in whatever is awarded by the court.
