## ALREADY FILED BANKRUPTCY? JOIN OUR MASS JOINDER LAWSUIT AGAINST JPMORGAN CHASE, EMC

The firm will file a MASS JOINDER lawsuit against JPMORGAN CHASE, CHASE subsidiaries and agents including EMC MORTGAGE CORPORATION on behalf of California homeowners facing foreclosure who have sought relief from the bankruptcy courts. The lawsuit will be used to stop foreclosure sales, facilitate loan modification and recover monetary damages.
