1/22/2011 Mass Hysteria - The Iabanez Decision by the Massachusetts Supreme Court. This is a very important case for homeowners, because Wells Fargo and US Bank got busted in the Massachusetts Supreme Court for failing to show up with documents that proved they owned the properties, and therefore had no right to foreclose. In plain English the court said that there are certain rules and the banks didn't follow them. So the banks couldn't foreclose. Here's one of the key comments by the court.

"... the legal principles and requirements we set forth are well established in our case law and our statutes. All that has changed is the (banks') apparent failure to abide by those principles and requirements in the rush to sell mortgage-backed securities."
