If you choose to look at some other companies please be sure that the company is attorney driven. The Attorney must be the one filing the compliance and must issue the **Cease and Desist letter to your creditors.** (other-wise it won't mean much) and they will continue to harass you. The Attorney's letterhead must be on all paperwork. Make sure you have control of your money and that the money is in a bank account in your name. Also, be certain that the attorney has your power of attorney for the settlement of your debts and he or she is the only one (besides yourself) able to withdraw money from your account. Be sure there are no start-up fees no termination fees and no late fees.
